INVESTMENT OBJECTIVE

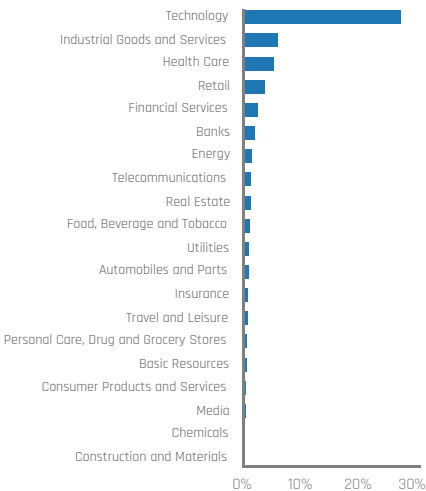

RISK INDICATOR (SRI)

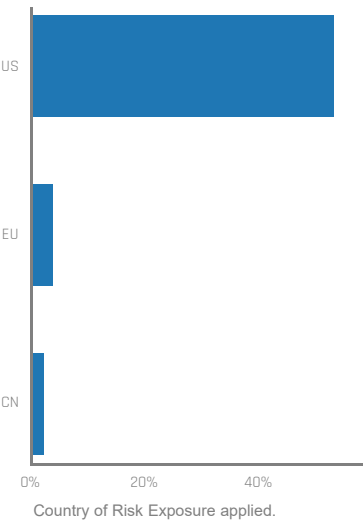
