### What is this product?

**Type**  
This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

**Term**  
This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

**Objectives**  
The objective of the Fund is to achieve a long term positive absolute return with a short-term moderate risk through a combination of capital growth and income, by investing in stocks and integrating environmental, social and governance (“ESG”) considerations.  
The Fund offers exposure to equity markets, investing mainly in global large capitalization stocks with a focus on the US. The Fund seeks to invest in companies with strong ESG practices and may exclude companies on the basis of their involvement in environmental damage, corruption, human rights issues or inappropriate labour practices.  
The Fund will combine a Top down and a Bottom-up approach to investments. The Top-Down approach, through Macro-economic analysis, will define the overall net market exposure. The average expected range of the net market exposure will be between 20% and 60% with a maximum of 100%. The Bottom-Up approach, through fundamentals analysis, will define the Fund exposure towards particular stocks and/or industries.

**Intended Investors**  
This Share Class is destined to Institutional investors, that can afford to set aside the capital for at least 2-3 years, whose investment objective is building up capital, and are able to accept moderate temporary losses.

*Depository:* CACEIS Bank, Luxembourg Branch

*Class Type:* This class is a capitalization class meaning that income is reinvested.

*Conversion right:* The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. Should we default, the investments are liquidated, and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.
