### What is this product?

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

Objectives

The objective of the Fund is to generate attractive risk-adjusted absolute returns by

investing primarily in a selection of equity and equity-related instruments. The selection aims at encouraging companies that improve the sustainability impact via "long" investments, as well as discouraging companies that worsen the sustainability impact via "short" investments.

Sustainability is determined taking in account the following environmental objectives, as foreseen by article 9 of Regulation (EU) 2020/852 of the European Parliament and of the Council of 18 June 2020 on the establishment of a framework to facilitate sustainable investment (the "EU Taxonomy Regulation"):

(a) climate change mitigation; (b) climate change adaptation; (c) the sustainable use and protection of water and marine resources; (d) the transition to a circular economy;

The Fund identifies the best opportunities in terms of current contribution and/or rate of variation for each Principal Adverse Impact indicator as well as financial perspectives. This approach offers investors a diversified exposure across all potential improvements of such indicators as well as a range ESG characteristics.

This Share Class is destined to Institutional investors, that want to contribute sustainability of financial investments and can afford to set aside the capital for at least 3-5 years, whose investment objective is building up capital and are able to accept moderate temporary losses

Class Type: This class is a capitalization class meaning that income is reinvested

#### What happens if KYRON Sustainable Long-Short European Equity Fund is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary CACEIS Bank, Luxembourg Branch. Should we default, the investments are liquidated, and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.
