What is this product?

Type

This product is a share of an investment company qualifying as an undertaking for collective investments in transerable securities (UCITS).

Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

Objectives

The objective of the Compartment is to generate attractive risk-adjusted absolute returns by investing primarily in equity and equity-related instruments issued by companies selected according to the "Investment Strategy" (as defined below). The selection aims at encouraging companies that improve the sustainability impact via "long" investments, as well as discouraging companies that worsen the sustainability impact via "short" investments.

Sustainability is determined taking in account the following environmental objectives, as foreseen by article 9 of Regulation (EU) 2020/852 of the European Parliament and of the Council of 18 June 2020 on the establishment of a framework to facilitate sustainable investment (the "EU Taxonomy Regulation"):

(a) climate change mitigation; (b) climate change adaptation; (c) the sustainable use and protection of water and marine resources; (d) the transition to a circular economy; (e) pollution prevention and control; (f) the protection and restoration of biodiversity and ecosystems.

To achieve the objective of sustainable investment, the companies selected as candidates for the "long" investments will qualify as environmentally sustainable.

Intended Investors

This Share Class is intended for prudent investors intending above all to preserve the invested capital while taking part in the opportunities for growth of the financial markets.

Other information

Depositary bank: CACEIS Bank, Luxembourg branch.

Class type: this class is a capitalization class meaning that income is reinvested.

Conversion right: the investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 3 years.

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary CACEIS Bank, Luxembourg Branch. Should we default, the investments are liquidated, and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

How long should I hold it and can I take money out early?
