The selection aims at encouraging companies that improve the sustainability impact via "long" investments, as well as discouraging companies that worsen the sustainability impact via "short" investments.

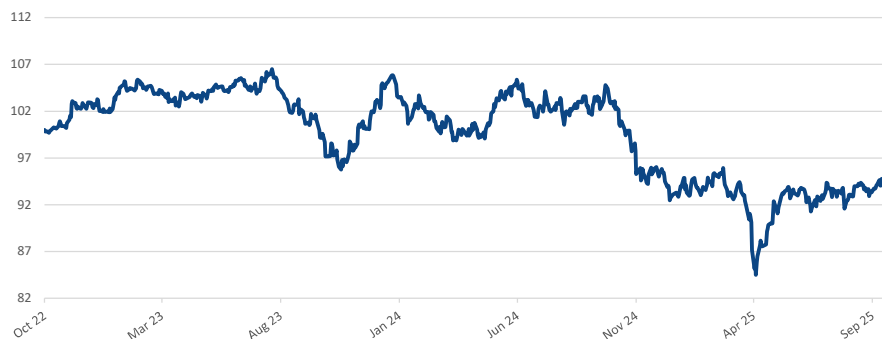

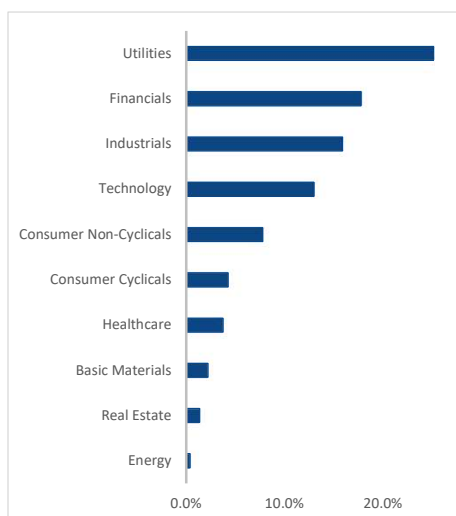

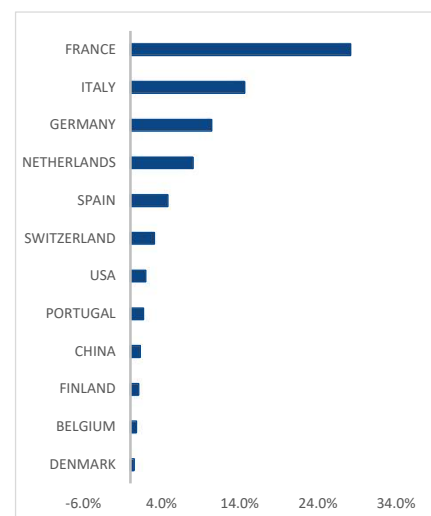
NAV SINCE INCEPTION
