What is this product?

Type

This product is a share of an investment company qualifying as an undertaking for collective investments in transcrable securities (UCITS).

Objectives

Investment objective

The objective of the compartment is to achieve a long term positive absolute return with a short term moderate risk through a combination of capital growth and income, by investing in stocks and integrating environmental, social and governance ("ESG") considerations.

Investment policy

The compartment integrates ESG characteristics into its selection process, promoting environmental and/or social aspects under Article 8 SFDR and assessing factors such as corporate strategy, governance, transparency and product/service range. It invests mainly in global large-cap equities, with a focus on the United States. Indirect investments in UCITS may not exceed 10% of net assets, while investments in other UCIs are not allowed. The compartment may use financial derivatives both to gain exposure to equity and currency markets and for hedging purposes. Its strategy combines a Top-Down approach (macroeconomic analysis to define net market exposure, expected between 20% and 60%) and a Bottom-Up approach (fundamental analysis of stocks/sectors), without systematic sector bias. Investments are mostly denominated in USD; exposure to non-developed markets is residual (up to 10%), excluding Russia and China. For liquidity management, the compartment may invest up to 40% in government debt and/or Green Bonds rated at least BB+, whose proceeds are specifically allocated to environmental and/or social projects. On an ancillary basis, it may invest in short-term bonds (<12 months), money market funds, listed instruments and money market instruments. It may also hold up to 20% of net assets in liquid assets (deposits and cash) for operational purposes, pending investments or adverse market conditions, with the possibility to temporarily exceed this limit in exceptional circumstances in the best interests of investors.

Intended Investors

This share class is intended for investors who:

- can afford to set aside their capital for at least 2 to 3 years;
- have an investment objective of building up capital;
- are able to accept moderate temporary losses.


Class type: this class is a capitalization class, meaning that income is reinvested.

Conversion right: the investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: the assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

What are the risks and what could I get in return?

We have classified this product as 3 out of 7, which is medium. In other words, the potential losses linked to future performance are at medium level and, if the market situation were to deteriorate, the ability of AISM Luxembourg S.A. to make payments could be adversely affected.

Be aware of currency risk. The amounts you will receive will be denominated in a different currency, so the final return you obtain will depend on the exchange rate between the two currencies. This risk is not taken into account in the above indicator.

Performance scenarios

What happens if AISM Luxembourg S.A. is unable to pay out?

In the event of the insolvency of AISM Luxembourg S.A., the fund's assets, held in custody with the depositary bank, will be liquidated by the latter and the proceeds distributed to investors. The depositary bank is legally required to segregate its own assets from those of the fund. Therefore, in the event of the insolvency of the depositary bank, the risk of financial loss to the product is mitigated. No compensation scheme or investor guarantee system is in place to cover any losses.

What are the costs?
