What is this product?

Type

This product is a share of an investment company qualifying as an undertaking for collective investments in transferable securities (UCITS).

Objectives

Investment objective

The Compartment aims to generate risk-adjusted absolute returns by investing mainly in equities and equity-related instruments. The strategy integrates sustainability criteria through long positions in environmentally sustainable companies with a positive impact and short positions in those with a negative impact.

Investment policy

The compartment has a sustainable investment objective, focusing on companies that improve at least one Principal Adverse Impact (PAI) indicator versus European Developed Markets, based on contribution, rate of change and financial prospects. At least 50% of net assets are invested in European companies, with no investments in Russia or China and no systematic industry bias. The portfolio invests mainly in equities and equity-related instruments through a long-short strategy with net long exposure of 20–70%. Companies with stronger ESG profiles are bought, while weaker ones are sold, making the portfolio on average better on PAI indicators and more aligned with the EU Taxonomy. Shorts are implemented via equity derivatives. For liquidity management, the compartment may invest up to 30% in government debt and/or Green Bonds (rated $\geq$ BB+) financing environmental/social projects. Indirect investments through UCITS/UCIs are limited to 10%, with restrictions waived during the first six months after launch. On an ancillary basis, it may invest in short-term bonds, money market funds/instruments, and listed assets. Up to 20% may be held in liquid assets, with temporary excess allowed in exceptional circumstances in investors' best interests.

Intended Investors

This share class is intended for investors who: - wish to contribute to the sustainability of financial investments; - can afford to set aside the capital for at least 3-5 years; have an investment objective of building up capital; are able to accept moderate temporary losses.

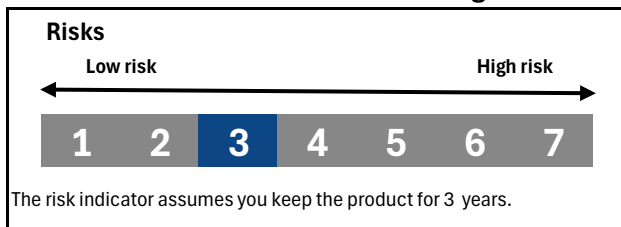
Class type: this class is a capitalization class, meaning that income is reinvested.

Conversion right: the investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: the assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

What are the risks and what could I get in return?

We have classified this product as 3 out of 7, which is medium. In other words, the potential losses linked to future performance are at medium level and, if the market situation were to deteriorate, the ability of AISM Luxembourg S.A. to make payments could be adversely affected.

Performance scenarios

What happens if AISM Luxembourg S.A. is unable to pay out?

In the event of the insolvency of AISM Luxembourg S.A., the fund's assets, held in custody with the depositary bank, will be liquidated by the latter and the proceeds distributed to investors. The depositary bank is legally required to segregate its own assets from those of the fund. Therefore, in the event of the insolvency of the depositary bank, the risk of financial loss to the product is mitigated. No compensation scheme or investor guarantee system is in place to cover any losses.

What are the costs?
